To Whom It May Concern:

This letter is to inform the County of Allegany, MD that the Town of Luke, MD 21540 will comply with the Tier 1 planning map that Allegany County has developed in compliance with Senate bill 236. Meaning all dwellings or public buildings in Luke will be required to hook up to public sewage. However this does not forfeit the Town of Luke, MD 21540 right to request tier changes in expanding future residential boundaries or areas that are not currently mapped as Town of Luke.

The Mayor and Commissioners offer full cooperation on these plans but do not at any point agree or disagree based on the current legislation. This agreement is to comply, not endorse the senate bill.

We acknowledge the Sustainable Growth and Agricultural Preservation Act of 2012 and are in agreement with Allegany County's map of our tier 1 status and adoption act. However we will at all times maintain our right to disagree and or protest any and all new laws that may be enacted at any time regarding this matter.

MITIGATION PLAN;


NOW, THEREFORE, BE IT RESOLVED, that the Town of Luke, hereby adopts the 2012


