RE: MDP's review of adopted tier maps; No comments

Thank you for providing the Department of Planning with a copy of the official Harford County Tier Map administratively adopted by Harford County on December 20, 2012. This action establishes growth tiers under the Maryland Sustainable Growth and Agricultural Preservation Act of 2012 for Harford County.

The Act allows the Department to comment on mapped growth tiers when the Department determines that the growth tiers do not meet the criteria established by the Act.

The Maryland Department of Planning is pleased to advise you that the official Harford County Tier Map administratively adopted by Harford County satisfies the criteria for designation of growth tiers under the Maryland Sustainable Growth and Agricultural Preservation Act of 2012. The Department therefore has no comments on the adopted map.

Please be advised that the growth tiers shall be incorporated into the County's comprehensive plan or an element of the plan when the County conducts its six year review of the plan. If the growth tiers are not incorporated into the comprehensive plan or an element of the plan during that 6-year review, Senate Bill 236 provides that the growth tiers may not be considered as adopted and the restrictions on major subdivisions outside sewered areas shall apply.

We received letters from the City of Aberdeen (November 16, 2012), Town of Bel Air (September 24, 2012), and City of Havre de Grace (October 17, 2012) that concur with the County's tier designations for the towns and their municipal growth areas.

Please note that some areas designated as "Agricultural" in the County's Land Use Map from the adopted 2012 Land Use Element Plan are designated as Tier III in the County's adopted Tier map; however these properties are zoned "Rural Residential." As a result, the land use designation and zoning are inconsistent. MDP encourages the County to review and reconcile the land use designation and zoning of these areas.

We would like to recognize the County's staff for their outstanding work in preparing the County's growth tier map.
